We have been self distancing for a couple of months, we have been staying at home, we have been wearing face masks, and we are now just starting to be able to go into restaurants. Some of us are depressed from being alone in our houses, not being able to go out and socialize.

For some of us it has also been learning experience. Our family have been having weekly meetings using "Zoom". This as well as being involved in several "meetings" using zoom or some other means of communication. Never heard of such things before this. We have been recording worship services using our cell phones. Who would have thought it?

But now the question is, where do we go from here? We are now able to go out in groups of up to ten. We are able to eat out again, under certain restrictions. Please be patient with our leaders as they try to work this out. We know that the Holy Spirit will guide us as we work through these unusual times. Pray that our leaders will be given the guidance to do the right thing that will allow us to gather once again for worship, but also keep us healthy.

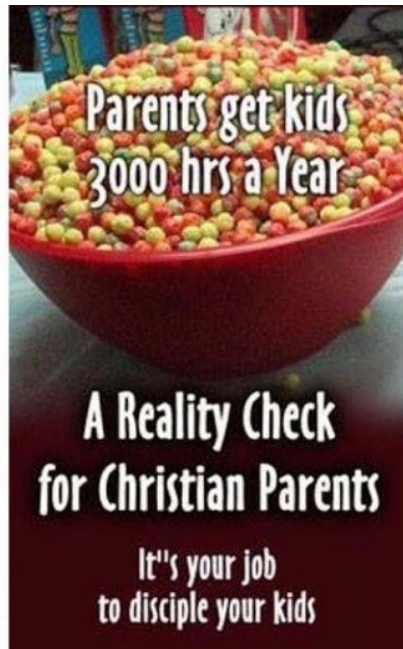
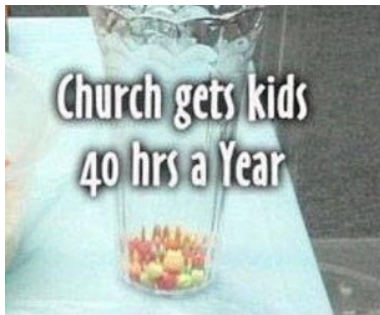
Regan Patten

I recently came across this poster that I thought to be very interesting. As you can see it show approximate hours that kids spend at school, at home with their parents and then how much time is spent in Church/Sunday School.

The reason I found this to be interesting is because I feel that when a child is brought to be baptized, the parents and sponsors agree to these following statements;

As you bring your child to receive the gift of baptism, you are entrusted with responsibilities:

- To live with your child among God's faithful people.
- Bring them to the word of God and the holy supper.

- Teach them the Lord's Prayer, the Creed, and the Ten Commandments.
- Place in their hands the holy scriptures.
- And nurture them in faith and prayer, so that your child may learn to trust God, proclaim Christ through word and deed, care for others and the world God made, and work for justice and peace.

Parents are then asked; Do you promise to help your child grow in the Christian faith and life? And their response is: I do

The congregation is also asked: People of God, do you promise to support and pray for this child in their new life in Christ? Response: We do

I find it ironic that some people think that it is the responsibility of the Sunday school to teach their child the things the parent promised to do at baptism!

Our volunteer teachers do their best to help bring the stories from the bible to your kids. They also do their best to make coming to Sunday school as fun and educational as possible. Curriculum from days gone by is just not available and our teachers have to use what is out there. It costs our Sunday school about \$300.00 a quarter for materials and our teachers do their best with that. But as you can see, it isn't only up to our teachers to teach your child about God and the Bible and the stories in it. As you promised, it is up to you to do this also.

During this time of the Covid-19 pandemic I have been taking bags around to our Sunday school kids. Some weeks there are Bible lessons for them and their parents to do. Are they doing them? I don't know. But they are being offered. I feel this is one way we can stay in touch with the kids and give the parents a chance to help their kids with reading the stories, reading from a Bible, and doing worksheets and activities together. It has been a joy to me to be able to talk to the kids through a window or door. But it also saddens me that that is the way it may be for a while.

So Everyone, please look over this chart, find it in your heart to help your child with those things you promised to do at their baptism. Especially now that we do not meet for worship or Sunday school in person, it IS your responsibility. And if we can be of any help, let us know.

Gail Lococo – donated a large box of material that was used to make masks that were handed out to our members and families.

Barb Wobser and Carol Dahs – these two ladies have been doing a lot of cleaning out of closets and rooms around the Sunday school areas.

And finally I want to thank Jim Bertsch, Russ Stephens, Barb Wobser, Pat Wiedenheft, Nancy Vollmer, and Ellen and Elise Kleinoeder for coming in on Friday mornings to help with the singing and responsive readings during the taping of the worship services. The extra voices are helping to make the service seem a little more real and it sure helps to be able to look out and talk to someone instead of a camera all the time.



## From the Worship and Music Team

At the last council meeting it was decided to continue to not hold in person worship services until after it is discussed at the next council meeting in June. But the Notification call committee was asked to contact people on their list and ask for an answer to the following question which came from the Synod office;

When would you be likely to return to Sunday morning in person worship at Trinity?

- When there is a Covid-19 vaccine.
- When Erie County has 14 consecutive days of decline in new Covid-19 infections.
- I am not comfortable with returning to in person worship at this time.
- When in person Sunday morning worship returns, I will be there.

The women on this committee are making these calls as the newsletter was in process of being printed. We will have these results to you via the church website or the church email and again in the July newsletter.

Please see the information, on the next page, that would have to take place in order for us to open again.

As you can see, we won't be able to just open the doors and walk in. A lot has to be done before, during, and after each worship service. And a lot of people are going to be needed to help!

Are you willing to help? Stay tuned!



After much discussion, it was unanimously agreed that, even though we all long to worship together, it would not be prudent at this point in time. The earliest opportunity to reopen would be the first Sunday in July.

These were the determining factors:

- 1. All guidelines from the CDC, ECHD, and the White House recommend waiting until infection numbers have dropped for 14 days. Erie County is seeing an increase in numbers. We will need to see if there is a surge in numbers two weeks from Mother's Day and again two weeks from Memorial Weekend.
- 2. The majority of Trinity's members are in the vulnerable category due to age, health conditions, or both.

These practices are encouraged to be continued:

- 1. Online Sunday services. Perhaps Brad Hoffman could be of help for camera work, bringing in outside sermons, and music.
- 2. Keep the coffee room closed.
- 3. No Sunday School or VBS.
- 4. Phone tree to keep members informed and involved. Remind members that God loves them whether they worship Him at home or in a pew.

The following areas could be addressed before moving forward:

- 1. All hymnals, pencils, cushions, blue cards, etc. should be removed from the worship space. They are not able to be disinfected.
- 2. Masks and hand sanitizer need to be available. Kathy Bango will look into this for us. All cleaning supplies need to be antiviral.
- 3. The AC needs to be checked. If it is used, it would be best if it brought in fresh air, rather than recycled air.
- 4. Look into online offering as a convenient alternative, as well as a way to reduce exposure to contamination for those handling paper envelopes, money, and checks.
- 5. As our liability insurance does not cover pandemics, consider either changing the policy or the carrier, or developing a waiver for members to sign. Pastor Cathy offered to look into this.

The problems to be addressed with reopening Trinity for in person worship are myriad. Among them:

- How to manage the volume of attendees. To keep a minimum of six feet between people means using every third pew (only 14 could be used), and having only one family or three unrelated people per pew. This would mean 40 to 50 people per service. Use an alphabetical plan for attending? Request reservations for the service?
- The church needs to be cleaned between services. Limit service to 60 minutes or less? Have attendees take their mask, bulletin, and all belongings with them? Have only one service? Have one time or an early service one Sunday, a late service the next?
- Attendance should be taken to help control the number attending and have a list of possible contacts if someone comes down with Covid-19.
- How to manage the flow of people. Close all but two doors? Have ushers be the only ones handling the doors? Have doors propped open? Have people released row by row, with ushers controlling spacing and discouraging gatherings? What about restrooms? Should someone leaving not be allowed to return to the sanctuary?
- Masks should be worn entering and leaving. Should we refuse admission to anyone who refuses to wear one?
- The service itself will need to change. No singing, no wind instruments for music, no communal prayers, no gathering at the railing for communion, only the wafer for communion, no children coming up for a children's sermon, and no common microphones are a few of the issues among others.
- Signage will be needed in the church building and all congregants will need information on the new procedures.

Obviously much prayer and planning is needed. The committee will meet again Thursday, June 11 at 7 pm.

# COUNCIL UPDATE

## TRINITY CONGREGATION COUNCIL Meeting Highlights - May 21, 2020 - 7:00 pm

(These are unapproved meeting minutes)

Attending: Barb Wobser, Dave Miller, Sally Warner, Jim Bertsch, Bonnie Lieb, Candy Beatty, Judy Driscoll, Pastor Ralph, Mike Markley, Pastor Cathy, and secretary, Carol Dahs.

Meeting called to order by President, Dave Miller.

Minutes of previous meeting (April 16) were reviewed. Sally made a motion to accept the meeting minutes. 2<sup>nd</sup> by Barb. Motion passed.

Treasurer's report for April was reviewed. Barb made a motion to approve the treasurer's report. 2<sup>nd</sup> by Candy. Motion passed.

President's Report: Candy gave an overview of her committee findings on how Trinity should proceed during the COVID-19 situation. After discussion Barb made a motion at the recommendation of Candy's committee that Trinity remain closed with July 5 being the earliest church would open. 2<sup>nd</sup> by Sally. Motion passed. Sally will have her Notification Call Committee make calls to members to get their input on some reopening questions. Much needs to be done before Trinity is ready to reopen. Dave still needs Adele signature on her review paperwork. The Transition team had a Zoom meeting and went through the survey results. They will meet again before the next council meeting in June. Dave will talk to Sherry Krieger on what Transition Team can do next.

Congregational Care Ministry Team – Barry Gill - They are awaiting guidelines on if/when to resume visits. At this point, the team members have been making telephone calls to keep in touch with our FAITH members.

Faith Builders – Barb Wobser – Sally has been taking activity bags around each week to the Sunday School kids.

Mission Service – Judy Driscoll – She delivered a large quantity of food to Grace's Table that was donated from Trinity members. She will have an actual count at the next meeting.

Property – Mike Markley – Barb made a motion to accept Brad Santoro's bid of \$5500 for the church and \$2000 for the parsonage to do tuck pointing work. The money donated from the Carol Towl estate of \$5,659 will be used for this project with the balance to be determined at the June meeting. 2<sup>nd</sup> by Candy. Motion passed. Brad has been paid \$3000 down to start. Brad is requesting a payment of \$2250 now with the balance of \$2250 being paid when work is complete. Bonnie made a motion to pay the \$2250 advance now. 2<sup>nd</sup> by Sally. Motion passed. Brad Santoro suggested that the church and parsonage be power washed and sealed. His estimate is \$3000 for the church and \$1500 for the parsonage. Council will present this at the Congregational meeting. Mike received two bids on pouring new concrete at the northwest church driveway. Brad Santoro bid \$6500 and Kreimes bid \$6200. This will also be presented at the Congregational meeting. Carol's new desk has been changed. Council approved \$750 for the first option. Mike & Maree Markley will cover the overages for the second option desk. Sally made a motion to have Kreimes seal and restripe the parking lot for an estimate of \$3648. The parking lot fund is \$170 short of covering this. Dave Miller said he would cover the overage. 2<sup>nd</sup> by Barb. Motion passed. Bill Klepper is working on the new step up to the altar.

Worship and Music – Sally Warner – A group has been videoing weekly church services on Friday mornings. Regan Patten will be recognized at the May 31 video service. Mueller Pipe Organ was in and did their six month tune up of the organ.

Old Business – Record retention cleanup is ongoing. Another fire safe filing cabinet has arrived to help this project.

New Business – FCEC (Faith Collaborative of Erie County) – has been disbanded. It can be taken off the Community Mission Fund Allocations. Carol and Barb suggested some paint colors for Sally's new office. Mike will investigate them. Dave will talk to Adele about when she is comfortable to come back to church for services.

If the situation is a **NON-EMERGENCY** situation, please contact the church office at 419-626-0204 during the hours of 9:00 a.m. and 1:00 p.m.; Monday through Friday, and speak with Church Administrator, Carol Dahs. You may also call the church office at any time and leave a message, requesting Pastoral Care, and someone will return your call.
